  - (d) 2022/0608/FUL Creation of a field access (retrospective). The Old Parlour, Fosse Road, Oakhill **Update** Stoke St Michael Parish Council recommend approval as there were no valid reasons to object.

  - (a) 2022/0437/PAH The erection of a single storey rear extension which would extend beyond the rear wall of the original house by 5.6 metres, with a maximum height of 2.8 metres and an eaves height of 2.8 metres. 16 Moonshill Road, Stoke St Michael. **Update** Prior Approval is not required.
  - (b) 2021/2831/REM Approval of reserved matters (Access, appearance, landscaping, layout and scale) following outline approval 2018/1913/OTA for the erection of a single dwelling. Land at 366414 146838, Stoke Hill, Stoke St Michael. Update The application has been withdrawn.
  - (c) 2021/2518/FUL Change of use of land from agricultural to dog exercise field (sui generis) to include fencing, parking and access. Manor House Farm, Burnt House Lane to Towns End, Stoke St Michael. Update Mendip District Council have approved the application.
  - **(d) 2022/0036/HSE** Erection of a side extension East Phippens Farmhouse, Fosse Road, Stoke St Michael. **Update** Mendip District Council have approved the application.
  - (e) 2022/0074/APP Application for approval of details reserved by conditions 3 (External Lighting, 4 (Ecology Nest Boxes), on planning consent 2020/2176/FUL Barn Farm, Tadhill Lane, Stoke St Michael **Update** Mendip District Council have approved the application.

## 12. Planning Applications being Monitored

(a) ENF/2021/0090 Construction of stoned farm tracks across 35 hectares of agricultural farm land to be used for walking, cycling, and bridleways. Cooks Wood Quarry, Bector Lane, Stoke St Michael. The application was withdrawn on 1<sup>st</sup> March 2021 and an enforcement case was requested due to part of the application was for retrospective planning. The Enforcement Team have confirmed a case has been opened and that discussions are taking place regarding a resubmission **Update** The enforcement team were contacted on 12<sup>th</sup> March for an update and the following was received. "Under the General Data Protection Regulations, the Council has a duty to protect the privacy of the person who is the subject of the complaint as we do for the person reporting the complaint. Therefore, we are no longer able to provide you with any updates or information about the matter during the course of our investigation. Such information is also likely to be exempt from release under the Freedom of Information Act 2000. You will be provided with a summary of our findings once the investigation has been concluded."

## 13.To Be Resolved/Discussed

- (a) Proposal to approve the application to Wainwright's community fund.

  Cllr Simon Farnsworth handed out a draft version of the application, this will be amended slightly and submitted. The Council have also received permission from the landowner to site the new dog bins. The land is privately owned.
- (b) The Village Design Code will be launched on Thursday 26<sup>th</sup> May in the Village Hall. The War Memorial Hall will be open between 10am and 8pm for residents to view the plans. Discussions on how the day will be run with maybe a Councillor rota.

The framework for the Village Design Code is in place and this will be launched on Thursday 26<sup>th</sup> May at an all-day Drop-In event. Villagers are welcome to come along to the War Memorial Hall between 10am and 8pm view the structure and timescale of the Design Code. Rob Palmer and Helen Little from Mendip District Council Planning Department will be in attendance along with Councillors. Cllr Amanda Taylor asked Councillors if they would consider helping to man the day and this will be discussed again at the next meeting.
