 - (d) APP/E3335/W/23/3332581 Land to the East of Church Street, Stoke St Michael. Decision The appeal has been dismissed.
 - (e) 2021/2519/LBC Change of use of the land from agricultural to dog exercise field (sui generis) to include fencing, parking and access. Manor House, Burnt House Lane to Towns End, Stoke St Michael. **Decision** The application has been withdrawn.

11. To Be Resolved / Discussed

- (a) Proposal to create a Working Party to create an Emergency Plan for the village. Cllr Dan White will compose a draft plan and bring it to the next meeting.
- (b) The Parish Council have received a written request following the formal closure of the churchyard at St Michael and All Angels Church in February 2024 to take on responsibility for the maintenance and care of the Churchyard. Following this formal request the proposal is to create a short-term working party to look at the implications of the Parish Council taking on the responsibility for the maintenance and reporting back to the next meeting where the formal response can be debated as the Parish Council have a three-month deadline in which to reply otherwise it automatically becomes the Parish Councils responsibility. An alternative proposal was put forward for the Parish Council to not take on responsibility of the maintenance for the Churchyard and defer the authority to Somerset Council, this was also seconded. The Council RESOLVED to not take on responsibility of the maintenance for the Churchyard and defer the authority to Somerset Council.

12. Clerk / Councillors Report

- (a) A new bus shelter has been ordered, installation will hopefully be in the middle of June, there will be a slight disruption as temporary traffic lights will be in place. **Update** The date of installation will be published on social media warning residents.
